THE WIN A LIFETIME OF GROCERIES/MY H-E-B APP SWEEPSTAKES OFFICIAL RULES

- **1. Sponsor's computer is the official time keeping device for the Sweepstakes.

During the Sweepstakes Period, entrants must first download the "My H-E-B" app (the "App") to their eligible mobile device via the App Store® (for Apple® devices) or Google Play™ (for Android™ devices). Entrants will open the App; create an account or log into their existing My H-E-B account; and select the section entitled "Win a Lifetime of Groceries!" in the App. After viewing H-E-B's big game commercial (online, in the app, or airing on TV starting 2/2/2020), follow the instructions in the App to select ten (10) H-E-B products shown in the commercial from the list of products presented. Once ten (10) correct H-E-B products are chosen, entrants can click the "Enter sweepstakes" button in the App to receive one (1) entry into the Sweepstakes. The registrant for the My H-E-B account logged in at the time of entry will be deemed the entrant. All entries must be received by February 16, 2020, at 11:59:59 p.m. CT. All entries are subject to verification by H-E-B, LP ("H-E-B" or "Sponsor") to determine eligibility. By submitting an entry, entrants acknowledge that they have read these Official Rules of the Sweepstakes, and they agree to be bound by them.
- **3. ELIGIBILITY.** To participate in the Sweepstakes, entrant must be a lawful permanent resident of the State of Texas, and be at least eighteen (18) years of age at the time of entry.
