## H-E-B Backyard Blitz Sweepstakes Official Rules

- 1. Sponsor's computer is the official time keeping device for this Sweepstakes. All drawings will be conducted by Sponsor in San Antonio, Texas.

4. **How to Enter:** During the Sweepstakes Period, visit www.heb.com/backyard (the "Website"), and complete and submit the Sweepstakes registration form, including a valid home address (P.O. Boxes are not permitted), day/evening/cellular phone number (if any) and email address. Each qualified online registration will constitute entry into that Weekly Entry Period's random drawing, as defined below, and one (1) entry in the Grand Prize drawing.
